Condo and Renters Insurance

The Homeowners association (HOA) in your condo building provides insurance, but there may be a reason for condo owners to have their own insurance. Generally speaking, the HOA-provided insurance covers the exterior of your unit and the building's common areas. Anything inside is the owner's responsibility. Think of the condo, as an article in AAA Motorist says, as a dollhouse. If you turned it over, everything that fell out would not be covered by the HOA.

Renters insurance policies usually include three types of coverage: 1) coverage to replace personal belongings lost to fire, some water damage, and theft or vandalism; 2) personal liability coverage in case of the owners' being sued and required to pay for property damage or bodily injury; 3) reimbursement for "additional living expenses" if it is necessary to relocate temporarily in the event of a covered loss. When Calling for Help

Over half of daily 911 calls are from Americans 55 and older. Below are some tips to help EMT's save a person needing help:

Clear the way: Trim bushes and low-hanging trees by the driveway. Have snow shoveled from the walk. Keep stairways in good repair.

Make your house a beacon: Make sure there is abundant lighting and that the house or apartment is clearly marked with an address or reflective paint on a curb.

Don't lock out EMT's or firefighters: Make a key available. One thing that can be done is a call to the local EMS with the location of a spare key. Breaking down a door requires extra time.

Declutter the house: Clear a path to all rooms where people spend time, and make certain there is open space around a bedbound person.

Keep records handy: Keep health "cheat sheets" on a refrigerator where they can be easily found. Include lists of medications, physicians, recent surgeries or necessary information.

Swap out confusing jewelry: Standard medical alert jewelry may not be fancy, but it is easily understood.

Alert EMS to special needs: Add a note to a home-address file if there are special needs for physical disabilities. (AARP Bulletin, December 2015)
